Sub: Customs-Conducting Examination for Customs House Agents
under Regulation-8 of CHALR-2004 in the year 2006 - reg.

It is proposed to conduct a written examination under Regulation -8 of CHALR 2004 (as amended) for Custom House Agents during the second fortnight of December 2006 as per the instructions of Directorate General of Inspection vide letter F.No.1191/6/2006-Confl. dated 25.10.2006. The venue of the examination will be New Custom House, Panambur, Mangalore.

2. The candidate authorized by the CHA licence holders should be employees of the licences and should possess the qualifications specified in regulation 6, which are as under:

- (a) Graduate from a recognized University and possesses a professional degree viz.,C.A/M.B.A/L.L.B/Diploma in Custom Clearance work from any Institute or University recognized by the Government with a working knowledge of computers and Customs procedures.

OR

- (b) A graduate having at least three years experience in transacting Customs House Agent work as a G-Card Holder.


OR

(c) A retired Group A Officer from the Indian Customs and Central Excise Service (IC & CES) having a minimum of ten years experience in Group A.

3. All the applicants who intend to take the examination may submit their applications giving their particulars in the enclosed proforma (alongwith recent passport size photograph and attested photocopy of regular licence) so as to reach this office on or before . 17.11.2006, 4 PM.

4. Attested copies of the documents in support of the qualification may be enclosed.

5. The applications received after the last date will not be considered for the above examination and no further correspondence in the matter will be entertained.
