

Applications are invited for selection of Special Public Prosecutors(SPPs) for handling CBIC cases as well as NDPS cases before the District & Session Courts of Mangaluru, Udupi and Karwar pertaining to Commissionerate of Customs, Mangalore.

All aspiring advocates who qualify in terms of Section 24(8) of the Criminal Procedure Code, 1973 and desirous to handle the CBIC cases on behalf of the Department may submit their application alongwith the Bio-Data in proforma "A" to "The Legal Section, Office of the Commissioner of Customs, New Custom House, Panambur, Mangaluru-575 010". The last date for the submission of application is 20.09.2018 at 18.00 hours. The proforma "A" can also be downloaded from departmental website [www.customsmangalore.gov.in](http://www.customsmangalore.gov.in).

The first engagement of an SPP shall normally be for a period of 18 months. Such engagement will be renewable on receipt of recommendation of the concerned Chief Commissioner along with the annual performance appraisal on completion first 12 months of the engagement.
